Thank you for your responses. After further discussions with Dr. Dallas and Dr. Scoresby, we've come to the conclusion that no further movement will be made with regards to case escalation or consultation with the board.

It will be framed strictly as a professional response after much debate and inquiry between Dr. Scoresby and I as pertinent to his initial report. Thank you for your patience, and I sincerely apologize for any upset this may have caused, particularly for Dr. Dallas.
